TOPIC: SEA CLIFF RETREAT, 1969 to 1982 - A PERSPECTIVE

Bluff retreat in San Diego appears to be less severe than that occurring elsewhere in California. Statements made in various studies of bluff retreat and slope stability include apparent discrepancies in measurements at the same locations.

Ernie's presentation suggests that an analysis of the existing works presents a more complete set of data points which may be utilized to prepare a more definitive paper.

The Department of Planning and Land Use has collected historic water level data for San Diego County from the Department of Water Resources and the U.S. Geological

Survey. Included in this data base are water level data collected by the County over the last year. In excess of 300 wells are included in the network and are located on a county-wide map. The data have also been tabulated to Township and Range location. The information is available at the Department from John Peterson (565-3042).

The Department of Planning and Land Use is working toward establishing a research investigation into groundwater recharge and flow within fractured rock. This investigation would be set up as a cooperative study between the County, U.S.G.S. and local technical community. The investigation would focus on one small watershed within the County and would monitor as many aspects of the hydrologic cycle as possible. In addition to this geophysical and geochemical studies would be conducted. The objective of the study is to evaluate groundwater recharge in the watershed so that the data could be used to appraise estimates for recharge in other areas of the County. One or more technical reports should result from the study. For additional information please contact John Peterson (565-3042).
