1998 SDAG FIELD TRIP UPDATE:

The theme of this year's trip is "Geothermal Resources and Geological Features of the Imperial and Mexicali Valleys". Tim Boardman's program at the August meeting will provide an introduction to the subject with the field trip to follow on the three-day weekend of October 9-12. Friday night will be a campout in the Imperial Valley. The tour of the Cerro Prieto (CP) geothermal plant and field, second largest in the world after The Geysers in

northern California, is scheduled for 10 a.m. to 1 p.m. on Saturday October 10. We will start at the CP Visitor Center about 25 miles south of Mexicali, viewing an excellent video on geothermal development in Mexico and touring the exhibits and displays. We'll then tour the field, observe surface features including bubbling mudpots, the Cerro Prieto and Imperial fault traces (dip-slip in this area), a recently erupted geyser, Volcano Lake, and the volcano. We'll then visit one of the three power plants which collectively produce 620 megawatts, enough to power 80% of Baja California (Norte) with ample reserves left to export to the San Diego/Imperial Valley region.

We now need volunteers to serve on the field trip committee to pull the rest of the program together. Meetings will be about one hour/month through October. Please contact Lowell Lindsay (numbers above) to volunteer or offer comments and questions.


