Dr. Brown has been on the faculty at Grossmont College since the late 1960's, and served as the Dean of Science in the 1980's. He has worked as a consultant for federal, state, and local agencies and private corporations. His most recent project (the topic of his presentation) is being funded by the Ford Foundation, and is a seven state study of western American irrigation communities in transition to be published late this year. 




